



## **Review Report**

The magnitude of the disaster of the earthquake on October 8, 2005 was incomparable to any in the last 100 years history of the region. The devastation was much greater than caused by the tsunami in Southeast Asia and affected an area covering around 2800 Sq Km and it left over a hundred thousand dead, four million homeless, thousands injured, women widowed and children orphaned in the thousands (a generation lost). Roads, communications and other infrastructure were severely damaged and schools, hospitals, government offices and banks were destroyed. A total of 9 districts in Azad Kashmir & Hazara Division (NWFP) were affected. It will take years to rebuild/relocate and reconstruct, but the physical and physiological damage caused to human beings will take a lot longer to heal.

The nation rose to the occasion despite the fact that no disaster management training or infrastructure existed. Help from home and abroad by organizations and individuals from all walks of life was overwhelming. The disaster management took place in phases of Rescue, Relief and Rehabilitation. While the Rescue part is over but Relief and Rehabilitation is an on going process and will require a lot more time and effort in the face of the colossal destruction.

Imran Khan Earth Quake Relief was formed immediately after October 8, 2005 and its team worked day and night to render help as part of its national duty. Shaukat Khanum Hospital, the biggest cancer hospital in the region, also provided medical help and medicines as a separate entity. In its humble capacity the IKERF team worked round the clock and provided relief to the victims in the areas and the details are provided in the subsequent pages in our audit report.

We are thankful to all our friends, associates and well-wishers who joined us in this noble cause. We are especially thankful to Jemima Khan and her friends for their financial assistance and the tons of goods sent by them. We would also like to appreciate the help of Dr. Nadeem Iqbal (UK), Mr. Nabeel (UK) and his brother Mr. Aneel (UK), Ali Zaidi of the Imran Khan Foundation (USA), Asim Ali Khan (USA), Kind Hearts (USA) and the countless other kind hearted people who gave us funds, shelters, goods, medical equipment, medicines and clothing, without which the relief effort was not possible. This teamwork was for a noble cause and all of us irrespective of creed, cast, religion or any social/political divide rose to the occasion to render help to all those who needed it the most. Though it is not possible to name each individual, but we do acknowledge with gratitude each one of you who helped the victims of the earthquake.

We conducted our audit accordance with generally accepted auditing standards. An audit includes examining on test basis, evidence supporting the amounts and disclosures in the accounts. An audit also includes assessing the accounting policies used and significant estimates made by management, as well as, evaluating the overall representation of the accounts. We believe that our audit provides a reasonable basis for our opinion.

As describe in Note 2, the financial statements have been prepare on the receipts and disbursement basis of accounting, which is a "comprehensive basis" of accounting other than generally accepted accounting principals.


#### OPINION:

In our opinion:-


- a) the payments made and or the expenditure incurred during the year was for the purpose of the approved objectives of the organization;

#### ACCOUNTING POLICES

Imran khan earth quake relief fund worked for welfare of affectees. Accounts were maintained on the basis of Non-Profit making organization and Receipt & Payment account was maintained accordingly. A central account with MCB was opened on 10 Oct 2005 and operated by following a strict policy as laid by managemet Board of the Imran Khan earth Ouake Relief Fund.

#### 2.1 Earth Quake Relief Efforts

In order to cater for the needs of the earth quake victims the fund took a two dimensional relief effort:

(a) To provide relief to those persons who migrated to settled areas Manshera/Abbottabad Hazara/Islamabad/Rawalipndi.



- **(b)** People who stayed in around the affected areas wre provided relief goods at respective sites in Azad kashmir/Hazara districts.
  - i For A & B above a Central Godown was establishes at 131 Kashmir Road Rawalipndi.
  - ii Goods from all over the country and abroad were stored category wise in the central Godown. From central Godown deliveries were made on actual need basis to Azad Kasmir and Hazara via forward distribution points in Abbottabad/Manshera (NWFP) and Bagh /Rawalakot / Muzzafferabad (Azad Kashmir)
  - iii A very brief overview is appended blow:

#### **PAYMENTS**

In order to provide timely help and in cost effective manner, the fund decided to make these to make and deliver shelters under direct supervision of IKRF team. Mr. Aamir Mehmood Kiani (Chief Operation IKRF) who hired some professionals in this filed and provided them required raw materials. For this purpose following material was purchased from the mentioned parties and labour charges were paid accordingly.

People who migrated to the camp areas like Rawalpindi/Islamabad were provided rations on weekly basis through proper registration to enable them meet their daily basic needs. Imran Khan Earth Quake Relief Fund registered 2000 (Two Thousand) affected families and provided them tents, blankets, clothes and weekly ration. These families were registered through their NIC's specific format. There was a close check to monitor that all dully registered families get ration on weekly basis.





#### 3.7 Medicines/Medical Equipments/Tents/Clothing/Rations

- (a) Two X-ray machines were given to Hospitals in Abbottabad Hazara
- (b) Pneumatic drill to Ayub medical College Abbottabad.
- (c) Life saving drugs/ MISC medicines to distt Hospital/ Ayub medical College Abbottabad-Hazara and to medical Camps in Distt Bagh, Muzzafferabad and Azad Kashmir.




